ORDINANCE 2017-O-13

AN ORDINANCE ENACTING AND ADOPTING A CAPITAL PROJECT ORDINANCE AUTHORIZING IMPROVEMENTS TO THE EXISTING GYMNASIUM AND SENIOR CENTER AND THE CONSTRUCTION OF A NEW GYMNASIUM.

BE IT ORDAINED by the Board of Commissioners of the City of Creedmoor that, pursuant to NC General Statutes Chapter §159-13.2, the following capital project ordinance is adopted:

Section 1. The project being authorized is the Gymnasium and Senior Center Renovation.

Section 2. The following amount is appropriated for the project: \$3,400,000

Section 3. The following amounts are appropriated for the project (Acct # 11-8000-3100):

Design Fees	\$ 300,000
Construction	3,000,000
FFE	100,000
Total Appropriations	<u>\$ 3,400,000</u>

Section 4. The following funding sources are anticipated to be available to complete the project:

PARTF Grant (Acct # 11-3100-0002)	\$ 500,000
Granville Co. Grant (Acct # 11-3000-0003)	350,000
Transfer from Capital Reserve (Acct # 11-3000-0015)	2,550,000
Total Appropriations	<u>\$ 3,400,000</u>

Section 5. The Capital Reserve Fund will appropriate funds as follows to fund the project:

Transfer to General Capital Projects (Acct # 15-7000-0011)	<u>\$ 2,550,000</u>
Total Appropriations	<u>\$ 2,550,000</u>

Section 6. The Finance Director is hereby directed to maintain with the Capital Project Fund sufficient specific detailed accounting records to satisfy the requirements of the restricted funds and generally accepted accounting principles.

Section 7. The Finance Director is directed to report as required on the financial status of each project element in Section 3 as requested by the Board of Commissioners or City Manager.

- Section 8. For purposes of cash management and financial reporting, any restricted funds used in this project will be deemed to be spent first. Any unrestricted funds available at project end will be returned to the General Fund.
- Section 9. Copies of this capital project ordinance shall be furnished to the Clerk to the Board of Commissioners, and to the Budget Officer and Finance Director for direction in carrying out this project.
