## **ORDINANCE 2017-O-15**

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF CREEDMOOR IN ACCORDANCE WITH ZMA-2017-04, WHEREBY APPROXIMATELY 75.54 ACRES OF LAND THAT IS LOCATED ALONG THE WEST SIDE OF HAYES ROAD (SR 1702) IS REZONED FROM RA-40 (GRANVILLE COUNTY RURAL AGRICULTURAL) DISTRICT TO SFR (SINGLE FAMILY RESIDENTIAL) DISTRICT

**WHEREAS**, an applicant has petitioned to amend the official zoning map by rezoning approximately 75.54 acres that is located along the west side of Hayes Road (SR 1702) in Creedmoor (MAPN: 180603417847), currently zoned RA-40 (Rural Agricultural) district by the Granville County; and

WHEREAS, the Board of Commissioners has previously adopted Resolution 2017–R–23, an initial scheduling resolution for ZMA-2017-04 HOBGOOD – HAYES ROAD, setting the date of public hearing for this zoning map amendment and authorizing the City Clerk notify the public in compliance with North Carolina General Statutes; and

**WHEREAS**, a public meeting was held by the City of Creedmoor Planning Board on September 14, 2017, to consider this zoning map amendment; and the Planning Board unanimously found ZMA-2017-04 consistent with the goals of the City of Creedmoor's CITY PLAN 2030; and

WHEREAS, the Planning Board has recommended approval of ZMA-2017-04 and has adopted a written consistency statement and finds this request consistent with adopted plans; and

WHEREAS, the Board of Commissioners held a public hearing on October 3, 2017, to consider said request, and gave the public an opportunity to be heard; and

**WHEREAS**, the Board of Commissioners concur with the Planning Board's consistency findings and have approved, by resolution, a statement of consistency and briefly explained why the board considers the action taken to be reasonable and in the public interest.

**NOW, THEREFORE, IT SHALL BE ORDAINED** that the City of Creedmoor Board of Commissioners hereby approves ZMA-2017-04 as presented and hereby authorizes an amendment to the Official City of Creedmoor Zoning Map reflecting such approval.
