## **Rookie Training Program**

Welcome to the Creedmoor Volunteer Fire Department, proudly serving our community since 1939. We are glad you have decided to serve your community by joining the department and volunteering your time. The following information and departmental guidelines are designed to help new CVFD firefighters learn the organizational structure and basic procedures of our department. All new members are placed on probation for one year. The rookie program must be completed within 3 to 6 months. After completion of the rookie program, a fire academy, or a CVFD training burn, and approval from your captain, you will be able to run calls and be awarded probationary firefighter status. You must complete your 1403 within a year and obtain your Firefighter I and II certification within 3 years. Upon completion of your 1403 you will receive your black helmet and interior firefighter status. Applicants who already have obtained their North Carolina State FF II Certification will be eligible for a Black Helmet with demonstration of basic skills and approval of the Fire Chief.

#### Orientation

Orientation is an evening class that will give you a lot of information about the department and about your membership expectations and benefits. Several items on your rookie check sheet can be signed off after orientation.

During orientation you will receive:

- Department Handbook
  - a. Rules and Regulations
  - b. Standard Operating Procedures/Policies
  - c. Rookie program sheets
- 2. Creedmoor FD rookie t-shirt
- 3. Essentials manual
- Turn out gear if available (to be kept at station until checked off to run calls)

Other items that will be given out by your Captain at their discretion once you have completed this program:

- 1. Pager
- 2. Fire Department license plate
- 3. Creedmoor FD duty t-shirt

Fire Department Class A and Class B uniforms, badge, and name tags will be issued at the end of one year probation.
