ORDINANCE 2018-O-01

AN ORDINANCE CLOSING THE TEN YEAR PLAN REVIEW & ENGINEERING PROJECT, JOINT LAPP PROJECT, CITY-WIDE STREET RESTORATION PROJECT AND CHIEF STREET PAVING PROJECT AND TRANSFERRING THE REMAINING FUNDS TO THE CAPITAL RESERVE FUND

WHEREAS, the City created the projects listed above by the adoption of Ordinances 2015-O-06, 2016-O-12, 2017-O-01 and 2017-O-05, respectively; and

WHEREAS, the City budgeted a total of \$3,158,930 for completion of these projects; and

WHEREAS, the projects are complete; and

WHEREAS, the City wishes to close the projects and transfer all remaining funds to the Capital Reserve Fund;

BE IT ORDAINED by the Board of Commissioners of the City of Creedmoor that, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following capital project ordinance is adopted:
