Proclamation

Modifying State of Emergency in the City of Creedmoor

Whereas a State of Emergency was issued for the City of Creedmoor and Granville County on

March 23, 2020; and

Whereas Governor Roy Cooper issued Executive Order No. 121, a stay at home order for the

State of North Carolina, which took effect on Monday, March 30, 2020; and

Whereas Governor Cooper issued Executive Order No. 141, lifting the stay at home order for

the State of North Carolina, which took effect on Friday, May 22, 2020 and allowed

North Carolina to enter Phase II of a three-phased reopening process; and

Whereas A modified State of Emergency was issued for the City of Creedmoor on May 22,

2020 lifting certain restrictions on the use of picnic shelters and picnic tables owned

by the City of Creedmoor; and

Whereas Governor Cooper issued Executive Order No. 163, moving North Carolina into the

next phase of a three-phased reopening process as of September 4, 2020 and relaxing

public health guidelines related to recreational activities and mass gatherings.

Row, Therefore I, Robert V. Wheeler, Mayor of the City of Creedmoor, pursuant to the authority

vested in me under Article 1-A of Chapter 166-A of the North Carolina General Statutes and Chapter 34.02 of the City of Creedmoor Code of Ordinances do hereby

proclaim:

Section 1. All provisions of Executive Order No. 163 remain in effect within the City of

Creedmoor.

Section 2. The State of Emergency declarations for the City of Creedmoor issued on March 23,

2020 and May 22, 2020 remain in effect, and are modified as described in section 3.

Section 3. Playgrounds: The prohibition restricting access to playground equipment owned by

the City of Creedmoor is hereby lifted, effective September 4, 2020 at 5:00 p.m.

Section 4. I hereby direct all City of Creedmoor law enforcement officers and employees and all

other emergency management personnel subject to our control to cooperate in the enforcement and implementation of the provisions of all existing emergency declarations, executive orders, applicable local ordinances, and state and federal laws.

Section 5.

I hereby order this declaration: (1) to be distributed to the news media and other organizations calculated to bring its contents to the attention of the general public; (2) to be filed with the City of Creedmoor Clerk; and (3) to be distributed to others as necessary to ensure proper implementation of this declaration.

Section 6.

This declaration shall take effect on the 4th day of September at 5:00 pm, and shall remain in effect until modified or rescinded.
